MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING (MOU) IS MADE ON **29-May-2026** BETWEEN M/s **ARJIT TRADERS**, Khasra No. 844, Kallipashchim, Raibareili Road, Lucknow - 226025 (Uttar Pradesh), (HERE IN AFTER REFERRED AS "AT") OF THE ONE PART AND M/s **ELMECH LABS PVT. LTD.**, A-37, SECTOR-63, NOIDA -201301 (HERE IN AFTER REFERRED AS "EL") OF THE OTHER PART.

IT IS HEREBY MUTUALLY AGREED AND DECLARED THAT FOR CONDUCTING TESTING OF MECHANICAL PROPERTIES, CHEMICAL COMPOSITION & METALLOGRAPHY, FOLLOWING SHALL BE THE RESPONSIBILITIES OF M/s **ELMECH LABS PVT. LTD.** AND M/s **ARJIT TRADERS** TO SUCCESSFULLY EXECUTION OF TESTING.

The terms of MOU are given below:

A. Responsibilities of M/s ELMECH LABS PVT. LTD.

1. EL shall comply all the necessary rules for the conduct of mechanical properties, Chemical composition, Corrosion, Metallography & NDT (UT, PAUT, RT) in accordance with IS, BIS, ASME, ASTM & IR codes etc.
2. Mechanical, Chemical & Metallography test would be done as per NABL scope.
3. UT & PAUT tests will be done by minimum of ASNT Level II certified person.
4. Radiography would be done by the person holding Minimum Level II and agency must be approved by BARC/AERB.
5. EL will submit test reports within 3 days after the conduct of test.
6. EL will share the NABL Scope and necessary certificates with AT.

B. Responsibilities of M/s ARJIT TRADERS:

1. The AT will provide the necessary test coupons & the detail of testing.
2. The AT will make payment within 30 days from the date of invoice.

C. Period: The MOU shall be valid for 5 Years from the date of its initiation.

D. Arbitration Clause:

On the aspects where the Articles of this MOU are silent or for cases relating to deviation from these articles, efforts would be made to resolve the issues through mutual dialogues and consultations between EL and AT.
